eligible staff as per the norms of the department. Then  
the school shall dispense with the services of unqualified  
and overaged staff, if any, immediately.
3. That all the facilities prescribed under Rules 50 & 51 of  
D.S.E.R., 73 shall be made available to the students.  
Provisions of Rules 5, 7, 8 & 9 be strictly observed.
4. That a proper library shall be established and facilities  
for reading room shall also be made available for students  
as well as teachers. Books as per the ratio of 16 books  
per student may be added and facilities of reading room  
may also be provided immediately and more books worth  
Rs. 500/- be purchased by the start of the next session  
and the list of books are furnished to the Education  
officer for verification.
5. Adequate sports material shall be purchased and made  
available to the students immediately.
6. That the school shall equip the Science Lab. as per the  
norms of the department and suitable facilities for  
practical work shall be provided to the students. More  
material worth Rs. 500/- shall be purchased during the  
current session and a list be furnished to the Education  
officer for verification.
7. That the school shall admit student without any discrimination  
of caste and creed as per the norms of the Deptt.
8. The payment shall be made as per provisions of section  
19(1) of D.S.E.R., 73 to all employees. The staff should  
be paid full salary with allowances through cross cheque  
before 15th of every month.

- That the arrangement of good drinking water shall be made available to all the students/teachers and sanitary facilities shall also be provided to the students immediately.
10. Fresh Health certificate may also be obtained from H.C.D. within a month and submitted to the Education office for verification.
1. That the enrolment in each section shall not exceed the number of students calculated @ 17 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi. In each class, Number of officiates required for proper functioning of the school should not exceed the number of officiates required for the managing committee will be asked by the D.E.S. (Apt) to be appointed in accordance with the provisions of the school management scheme of Management.
2. That Govt. Nominees in the decisions of the Managing Committee of the school shall not enhance the fee during the ensuing academic session without the prior approval of the Director of Education which is mandatory requirement under sub-section (3) of section 17 of Delhi School Education Act, 1973 and shall regulate the functioning of the school strictly in accordance with the provisions of the Act and Rules.
3. That the Managing Committee of the school shall not start without the prior approval of the Director of Education.
- That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school.
- That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer within six months.

Books as per ratio of 10 books per student may be added and facilities of reading room may also be provided immediately and more books worth Rs.15,000/- be purchased by the start of next session and the list of books are furnished to Education Officer for verification.
- Adequate sports material shall be purchased and made available to the students immediately.
- That the school shall equip the Science Lab.s as per the norms of the Deptt., and suitable facilities for practical work shall be provided to the students. More material worth Rs.15,000/- shall purchased during the current session and a list be furnished to the Education Officer for verification.

- That Govt. nominee in the Managing Committee will be asked immediately, and all decisions will be taken in accordance with the provisions in the approved scheme of management by the DDE(Act).
  - The Managing Committee of the school shall not enhance the fee during the ensuing Academic Session without the prior approval of the Director of Education which is a mandatory requirement under sub-section(3) of Section 17 of Delhi School Education Act,1973 and shall regulate the functioning of school strictly in accordance with the provisions of "the Act & Rules".
  - That the Management of the school shall create a Reserve Fund of Rs.2 Lac +80 Rupees per student only in a Joint Account in the name of the Director of Education and the Manager of the school in any schedules bank within a month.
  - IXth class should not be started without the prior approval of the Director of Education.
  - That the violation of any instructions/orders/conditions/rules and regulations of the Deptt. shall lead to the withdrawal of recognition of the school.
  - That the school will return the recognition of MCD if obtained earlier.
  - That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six month.
